



PROVING LEGAL DAMAGES AFTER A BIKE ACCIDENT

You've been hit by a car while cycling and seriously injured. What should you do regarding a personal injury claim?

First, the driver of the car must be shown to be negligent. If this is the case, then there are important steps to follow to ensure you get the full compensation you deserve for your injuries:



MEDICAL EXPENSES

If you do incur medical expenses, then the drivers' insurance company will be responsible for reimbursing you for the cost of those bills.



Legal Tip: Promptly submit all related medical expenses to your health insurance company. You are entitled to be fully reimbursed for expenses by the person who hit you or their insurance company.

LOSS OF INCOME

If you miss time from work, or otherwise lose income due to your inability to work because of injuries, then those amounts must be paid as well.



Legal Tip: Document all lost earnings with pay stubs, copies of past tax returns and any statements from your employer.

PAIN & SUFFERING

Coming up with a compensation figure is very subjective, so the best thing to do is keep a daily journal of how your activity is affected by your injury, and the impact it had on your life.



Legal Tip: *Document, document, document!* Document your medical bills, lost earnings, and the impact of an injury on your life. Insurance companies will not just take your word for it. The burden is on you to prove it to them, and the more hard evidence you can provide, the better off you will be.
